Per Chapter 3, Section 14 of the Regulations for AKC Scent Work, it is not appropriate to visit the trial location prior to the trial date. Many search locations are real-life environments and such visits may risk the host losing the opportunity to use the location in the future.

DIRECTIONS TO TEST HEADQUARTERS FROM I-75, LEXINGTON

These trials are being held in conjunction with the Bluegrass Classic Dog Shows at the Kentucky Horse Park. From I-75 to Iron Works Pike (Exit 120), approximately 5 miles north of Lexington. Follow Horse Park signs and enter through the Main Gate to Cigar Lane to Miller Barn #22 (next to Alltech Arena).

PARKING AND FEES

All attendees/exhibitors for any of the Bluegrass Classic dog events will have free entry into the Kentucky Horse Park. Please tell the attendant at the Main Gate that you are there for the Bluegrass Classic Dog Show to receive free entry into the Horse Park. SAVING PARKING SPACES IS NOT ALLOWED. No parking spaces may be saved with cones or by any other method.

There is an admission charge to the Alltech Arena which includes all of the dog events (Scent Work, Conformation, Lure Coursing, Dock Diving, Rally, and Obedience) which is \$7 per car load per day or \$30 for a 5-day Event Pass which includes in/out privileges. Event Pass can be purchased at Alltech gate.

ENTRY METHOD, LIMIT, DATES, AND DRAW LOCATION

ENTRY FEES PER TRIAL

Entry fees are **\$25 for FIRST CLASS ENTRY PER TRIAL, \$20 for EACH ADDITIONAL CLASS ENTRY PER TRIAL** and include \$3.50 AKC recording fee. Mail entry forms and fees to Event Secretary. No entries will be accepted by phone, e-mail, or fax. Express mail entries must include signature waiver. No entry shall be made or accepted which specifies any conditions as to its acceptance. Illegible entries will not be processed and will be returned to the exhibitor.

Entries for the Random Draw will be taken between 9 AM on July 18, 2018 and 5 PM on August 1, 2018. The drawing will be held at 7 PM on August 1, 2018 at 100 Par Lane, Elizabethtown, KY. The public is invited to attend. If necessary, a draw for a wait list will be held from the remaining entries after limits have been reached. Entries will be accepted until the Close Date of August 13, 2018, at 5 PM. If published limits are not exceeded during the Draw Period, all entries received after the Draw Period will be accepted under First Received method. If limits are exceeded at the Draw, additional entries will be added to the wait list in the order received.

ENTRY AND NOTIFICATIONS

Entries must be made on an Official American Kennel Club Entry Form, signed by the actual owner or duly authorized agent. Returned checks do not constitute a valid entry fee. Collection fees of \$25 will be added to the amount of each returned check. Do not send entries by any method which requires a signature for acceptance. ***Cancellation of entries must be made in writing and received prior to the stated close of entries.***

As soon as practical after the Draw Date, entries will be notified of their entry status. A Judging Program will be emailed to the entrants as soon as practical after the Entry Closing Date. Should you not receive such notification within a reasonable amount of time, please contact the Event Secretary.

INVALID ENTRIES

Entries received prior to the Draw Open Date shall be treated as an invalid entry and will be returned to the sender. ***Envelopes containing entries for more than 5 dogs will be considered invalid entries. Each entry form must be accompanied by separate checks. Multiple entries paid for with a single check will be considered invalid entries. Replacement checks will be requested and must be received prior to Draw Closing Date for entries to be included in the draw.*** Entries received after the Entry Closing Date will be treated as invalid entries and will be returned to the sender.

DOGS ELIGIBLE TO ENTER

Trials are open to all dogs SIX (6) months of age or older that are registered with the American Kennel Club or that have AKC Limited Registration, Purebred Alternative Listing/Indefinite Listing Privileges (PAL/ILP), and AKC Canine Partners listing number, or approved Foundation Stock Service (FSS) breeds are eligible to participate. Dogs with PAL/ILP or an AKC Canine Partners listing number must be spayed or neutered in order to compete. Dogs with physical challenges (including amputees) are eligible to participate provided that, in the opinion of the judge, the dog displays no sign of physical discomfort and can safely complete the search. Deaf and blind dogs are allowed to enter.

Aggressive dogs or dogs suffering from an injury or illness which may affect the dog's physical or mental performance may not participate. No dog shall compete if it is sutured, bandaged, or has any visible wounds.

BITCHES IN SEASON

Bitches in season MAY NOT participate. Refund of entry fees for bitches entered in the Trial that come in season after the closing date may be obtained by providing a veterinarian's certificate to the Event Secretary no later than 30 minutes before the start of the first class on the day of the trial.

WAITING LIST

A wait list will be established to fill openings created by withdrawn entries after the trial's closing date and time. A maximum of 20 entries per day will be placed on the wait list. All entries, including wait-listed entries, must be received by the Event Secretary prior to the Event Closing Date and Time. Any wait list entry that does not move off the wait list into the trial will receive a full refund.

REFUNDS

No entry fee will be refunded if the trial cannot open or be completed by reason of riots, civil disturbances, fire, and act of God, public emergency, act of a public enemy, or any other cause beyond the control of the organizing committee. No entry fee will be refunded in the event a dog is absent, disqualified, excused, or barred from competition by action of the Event Committee. Entries withdrawn for any reason after closing date and time are not eligible for a refund unless their entry is replaced by a wait-listed entry (except for bitches in season).

CLASS TRANSFERS

A move-up transfer may be requested if, according to the owner's records, the handler and dog are eligible and the dog has completed the requirements for the title after the closing date of the trial in which the advanced entry is to be made. A move-down transfer may be requested if the owner mistakenly entered the dog in a higher level class for which it is not eligible. A lateral transfer may be requested if the owner mistakenly entered the dog in Novice A and it is not eligible. The request for a class transfer must be submitted in writing to the Event Secretary at least 30 minutes prior to the start of each trial. Transfers may be approved provided the class is available and has not reached its limit, if there is one.

EXHIBITOR CHECK-IN

Exhibitors must check in at each trial they are entered. At check-in, exhibitors will receive their number.

Judges are not required to wait for dogs. The owner/handler of each dog is solely responsible for having it ready at the search area when it is to be judged. The Club has no responsibility to provide service through a public address system or stewards or runners for the purpose of calling or locating dogs that are not brought into the ring when required.

HANDLING MORE THAN ONE DOG

Handlers may not handle more than one dog in each class with the exception of the Handler Discrimination classes. Multiple dogs from the same owner may be entered in the same class provided they are run by different handlers. Novice A and Novice B are considered to be different sections of the same class. (AKC Scent Work Regulations Chapter 2, Sections 10 & 11).

POSSESSION OF ODORS AND TRAINING

Per Chapter 5, Section 30 of the AKC Scent Work Regulations, no person other than those engaged in the administration of a trial shall be in possession of any target odor when on the trial grounds. There shall be no training on the grounds of an AKC Scent Work trial other than in the designated warm-up area if there is one.

AWARDS

Ribbons will be offered for Qualifying Scores. Rosettes will be offered for New Titles, Class Placements First through Fourth, High In Trial Novice, High in Trial Advanced, and High in Trial Excellent.

HIGH IN TRIAL

Only teams who participate in the same difficulty level in all elements offered and qualify in each are eligible to win High In Trial. High in Trial is determined by adding a team's faults across all elements. The team with the fewest faults will be declared High in Trial. If there is a tie based on faults, then the teams times across all elements will be summed and the faster finishing team will win. If there is still a tie after considering both faults and time, HIT will be decided by a coin flip. There shall be one HIT winner for each difficulty level offered. There is no separate HIT for Novice A and Novice B. Teams winning HIT will be awarded a rosette.

MAINTAINING THE INTEGRITY OF THE SEARCH

Handlers may not divulge any information about the search, the location of the hide(s), or their performance aside from a thumbs up or thumbs down until all teams have run for the particular class. If anyone is found to be discussing a search before the class has ended, both parties in the discussion (speaker and listener), will be penalized with a "Not Qualified" score (NQ) for the class. Additionally, at the discretion of the event committee, persons discussing a search may be excused from the trial and asked to leave the trial grounds. (AKC Regulations for AKC Scent Work Chapter 2, Section 12).

SEARCH AREA AND CONDITIONS

Searches are frequently done across natural, uneven surfaces and handlers should be aware of and prepared for this possibility. Many searches are conducted outdoors. Therefore, handlers should be prepared for all potential weather conditions. Handlers should understand that searches will be conducted rain or shine unless dangerous conditions are present such as lightning or flooding. Comfortable footwear and water-resistant clothing are recommended. (AKC Scent Work Regulations Chapter 2, Sections 15 and 16)

STAGING AREA, HANDLER'S BRIEFING, AND WARM-UP INFORMATION

The Staging Area will be out of view of search area(s). Staging area will include crating, warm-up, and waiting area, as well as the secretary table for check-ins and posting of running order and results.

The Handler's Briefing will take place in view of the search area prior to the start of each class, after the hide(s) have been set and after the Demo Dog has run. In the Handler's Briefing, the judge will explain if there's an off-leash option, number of hides, maximum height of hides, and maximum time for the search. NO DOGS are to be present during the Handler's Briefing.

A Warm-Up Area will be available consisting of ONE marked container of each odor being tested at the trial and may also consist of blank containers. Exhibitors should limit their warm-up to TWO (2) minutes or less. The warm-up area is to be used exclusively for warming up the handler-dog team prior to their run. The warm-up area is not for training or relieving of the dog.
